#### **EXAMPLES OF WORK:**

Responsible for managing, developing, and ensuring the integration of spatial and tabular databases and documentation related to the diversity, distribution, extent, and conservation status of Nebraska's species of concern, ecological communities, and important conservation areas. Database management will include applying content and accuracy standards, writing database queries, creating custom database reports, working with staff biologists on biological data, and serving as the primary contact. Train and provide oversight for the Natural Heritage Data Technician whose duties include creating and processing spatial data, transforming field-survey data into spatial data, incorporating data into the Program's primary spatial database (Biotics), and documenting data sources and processing steps applied. Work closely with NGPC staff and other conservation entities to develop and manage data, acquire and create GIS datasets, create applications, perform analyses, and design/produce effective maps, reports, and other data products. Administer the spatial data of the Conservation and Environmental Review Tool (CERT), a customizable web application framework providing interactive access to natural resource data for conservation planning and automated environmental review screening, including creating, managing, and updating data sets, designing and configuring map

documents, providing technical support, and coordinating with I.T., biologists, environmental review staff, and NatureServe.
